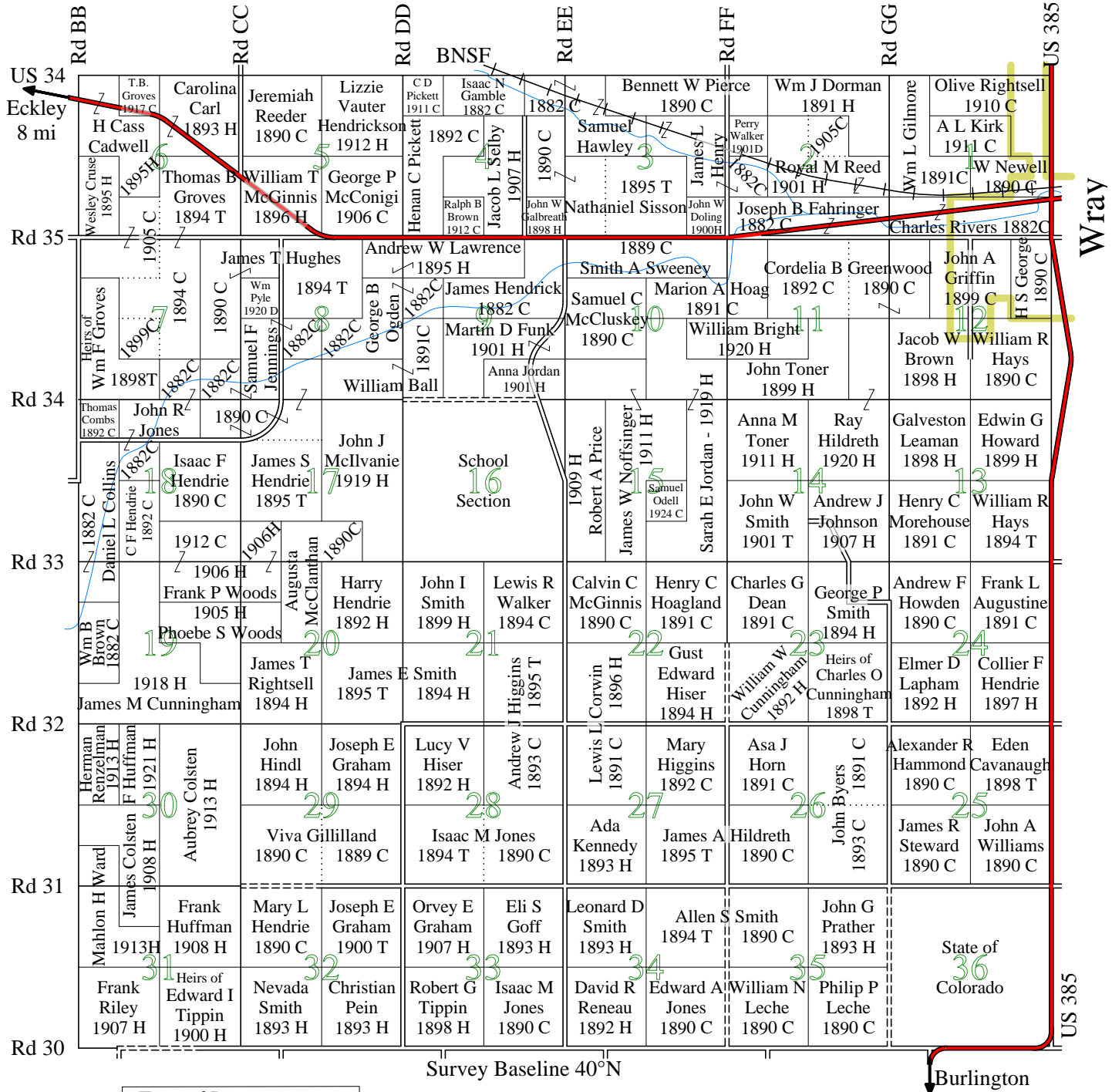


# Township 1 North Range 44 West Yuma County, Colorado
