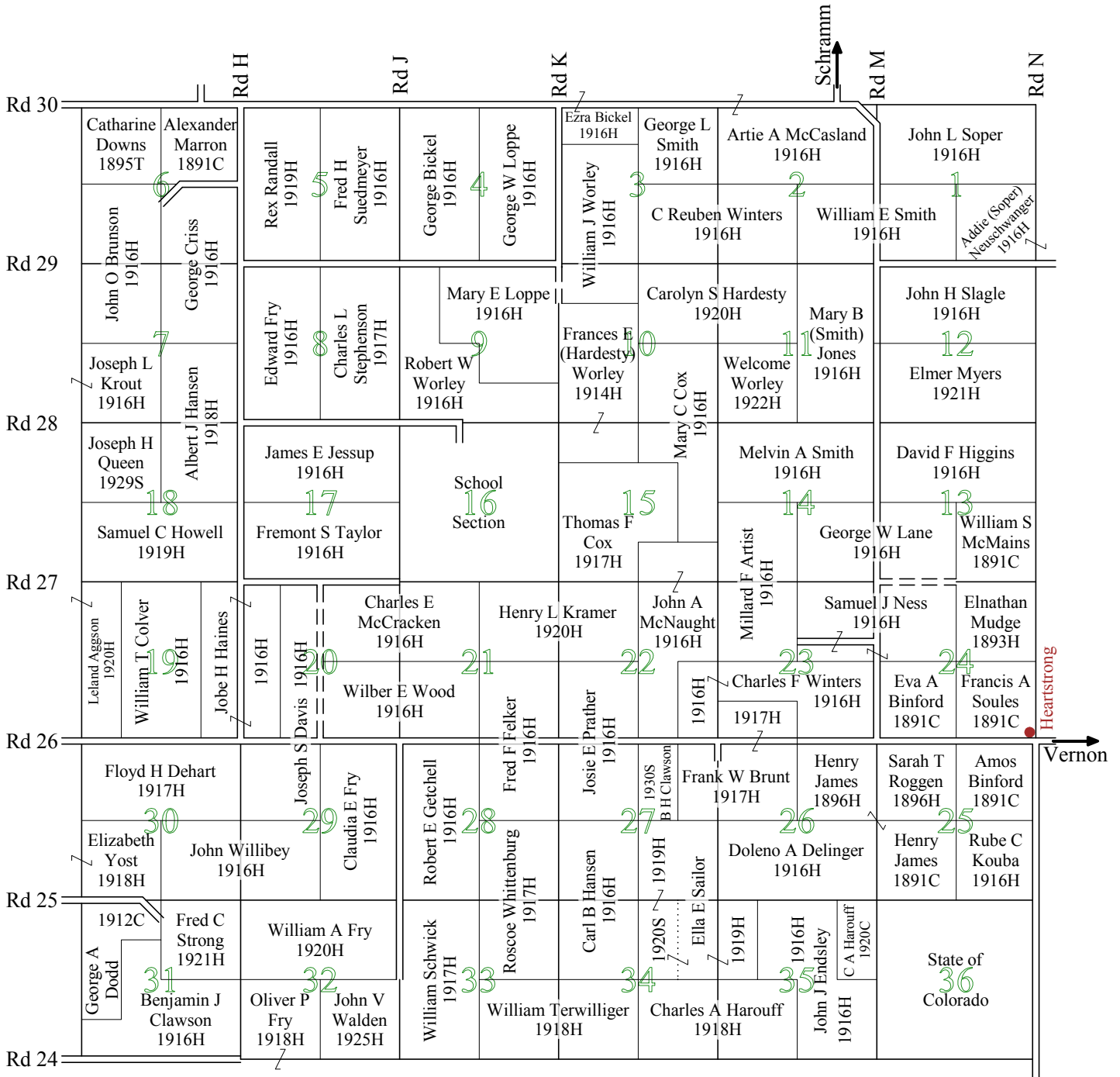

The 1889-1891 Avoca Post Office was located in this township but the quarter-section where it was located wasn't on the 1889 application. The book *Atlas of Colorado Ghost Towns* placed Avoca somewhere near the southwest corner of Section 36.
