There are no patents in the BLM GLO database for the NW¼ or SW¼ of Section 34.

Two 1899 homestead patents are listed for John E. Baxter in Sec. 7. The NE¼ Sec 7 is shown on the 1922 Ownership map as owned by W.E. Scheible while the other three 'Baxter' quarters agree with the BLM database which suggests an error with that patent.

Typographical errors abound in the database. For example, Charlie A Canon is shown in the database as "Canom." Armel Brenninger was shown as "Arnel". I'm sure many others got by me.

Notes (Continued):

The Armel post office was open from October 1903 to May 1958.

The Gurney post office was open in Colorado from September 1907 to September 1923.

The Rogers post office was open from May 1886 to September 1888.
